Bond of Indemnity

KNOW ALL MEN by these presents that We (a) _____ the son/daughter/wife of _____ resident of _____ (hereinafter called the "Claimant" and (b) _____ S/o, D/o, W/o _____ resident of _____, the Surety for and on behalf of the "Claimant" (hereinafter called the Surety) are held firmly bound to the Governor of West Bengal (hereinafter called "the Government") for the sum of Rs. _____ (Rupees _____ only) equivalent to the amount of _____ prize payable against ticket no. _____ of _____ (No. & Name of Draw) of West Bengal State Lottery and every sum being well and truly to be paid to the Government on demand and without a demur, for which payment we bind ourselves and our respective heirs, executors, administrators, legal representatives, successors and assigns by these presents.

WHEREAS the Ticket No. _____ of _____ (No. & Name of Draw) of West Bengal State Lottery has won the _____ Prize of the _____ (No. & Name of Draw) of West Bengal State Lottery conducted by the Directorate of State Lotteries, Government of West Bengal valued Rs. _____.

AND WHEREAS the claimant has represented that being the purchaser and owner of the above mentioned _____ prize winning ticket he/she is entitled to the aforesaid _____ prize as per condition pointed on the ticket and has formally put forward his/her claim for the same.

AND WHEREAS the Director of State Lotteries, being the authorized officer of the Government has agreed to make payment of the said sum of Rs. _____ to the Claimant upon the Claimant and the Surety entering into a Bond in the above mentioned sum to indemnify the Government against all claim to the amount so due to the bonafide _____ prize winner in the above said lottery :

AND WHEREAS the Claimant and at his/her request the Surety have agreed to execute the Bond in the terms and manner hereinafter contained;

NOW THE CONDITION OF THIS BOND is such that if after Payment has been made, to the Claimant, the Claimant and/or the Surety shall in the event of a claim being made, by any other person, against the Government with respect to the aforesaid sum of Rs. _____ (Rupees _____ only) then refund to the Director, State Lotteries the said sum of Rs. _____ (Rupees _____ only) and shall otherwise, indemnify and keep the Government harmless and indemnified against and from all liabilities in respect of the aforesaid sum and all costs incurred in consequence of the claim thereto THEN the above written BOND or obligation shall be void but otherwise the same shall remain in full force effect and virtue.

AND THESE PRESENTS ALSO WITNESS that the liability of the Surety herein under shall not be impaired or discharged by reason of time being granted by or any forbearance act or omission of the Government whether with or without the knowledge or consent of the Surety in respect of or in relation to the obligations or conditions to be performed or discharged by the Claimant or by any other method or thing whatsoever which under the law relating to Sureties, would but for this provision shall have no effect of so releasing the Surety from such liability nor shall it be necessary for the Government to see the Claimant before seeing the Surety or either of them for the amount due hereunder.
