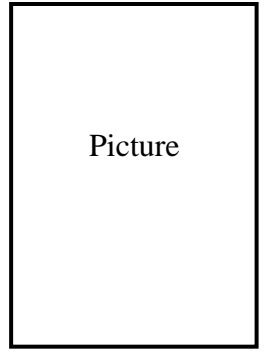

3. In case of Claimant is Minor than an Affidavit from the National Guardian/ Parent should be attached with the Claim Form.
4. The period of claiming the **Sub-Stockist Prize is 30 days**, after that no claim will be entertained.
5. **The Sub-Stockist must get the claim and invoice verified by the Distributor before submitting it to this office.**
